	<p>If yes, how would you address this issue?</p> <p>I am absolutely in favour of bringing back the community's ability to ask questions in the Council chamber without having to register to speak, submit them in writing first and I want to return to the 5 minute speaking time. Having pre-prepared responses to questions from the public has resulted in questions not being adequately responded to and is eroding community confidence in Council. If elected I will put forward a Notice of Motion in the first Council meeting to this end.</p>		
8Q.	Do you support improving the <u>transparency</u> to residents of the processes of planning within the City of Yarra and in particular those that relate to heritage <u>values</u> of any area under consideration of planning change or development?

	<p>If yes, how would you address this issue?</p> <p>Absolutely, YES. I want to see a review of the Governance rules around the number of objections required for a planning application to be heard at a Planning Decisions Committee, greater transparency of decisions taken under delegation by Officers and a push notification system implemented by Council to inform residents of planning applications in their area.</p>		
9Q.	The CoY Transport strategy has determined that on designated cycleways, angled parking will be replaced by parallel parking. If implemented in East Clifton Hill this will lead to a dramatic reduction in available parking in both Spensley Street and Roseneath Street. Both streets are relatively quiet, and we have no evidence to suggest that cyclist safety is an issue on these two roads. If elected, will you seek to ensure that angled parking is retained on both Spensley and Roseneath Streets?

	<p>If yes, how would you address this issue?</p> <p>Yes, I will immediately seek a review of the Transport Strategy and ensure angled parking is retained on Spensley and Roseneath Streets. I will ensure better community consultation on any changes proposed to current parking arrangements, seek public access to the data on cyclist safety and push for community cabinets to come up with solutions to any identified issues.</p>
